There have been a number of important regulatory updates over the last couple of years, all of which have contributed to improving the safety and compliance of fire doors.

This includes The Building Safety Act 2022 which has created pivotal change for the fire door industry and has tied together pieces of the legislation that came before it. The act stipulates the exact requirements for landlords, responsible persons and fire door inspectors, providing clear guidance and expectations to everyone involved in the safety of fire doors.

One of the key requirements in this act is that buildings over 11m high must inspect their residential doors on an annual basis, and communal doors within that building on a quarterly basis.

Regulation 10 is another important piece of the puzzle, which provides guidance on how to check fire doors and components.

Prior to the Building Safety Act, the Regulatory Reform Order 2005 (RRO) did stipulate that fire doors should be checked periodically but it didn't provide specific guidance on timings. This means that all fire doors irrespective of location should be checked regularly to ensure they are fit for purpose.

Changes and updates to building regulations, the testing of bi-directional doors, and the introduction of the golden thread have also impacted fire doors. These changes have impacted the specification of products, and the work of on-site trades people including fire door inspectors, installers and maintainers.
