

Sadly, poorly maintained fire doors were one of the key reasons why so many people lost their lives in the Grenfell Tower tragedy.



Fire doors are life saving products, and they will hold back fire and smoke if they are handled in the correct and compliant manner.



Over half of flat entrance fire doors were found to be noncompliant—mainly due to faulty door closers from the day they were installed and poor-quality repair work carried out afterwards, before the fire occurred.



Fire doors are not just standard doors—they're highly engineered, tested safety products. Each one is approved only after rigorous testing by the manufacturer, and it's crucial that they are installed, maintained, and inspected according to this test evidence.



Importantly, no two fire doors are the same. Different manufacturers use specific components and installation methods. That's why, by law, anyone working on a fire door must fully understand how that particular product should be handled, in line with current legislation and manufacturer guidance.


Am I competent already?




Demonstrating competence




